

#### What is the Conference on the Future of Europe?

A 1-year process of (online and offline) events and dialogue among citizens and politicians at all political levels, with the purpose of arriving at (commonly agreed) reform proposals for the future of Europe.




Why is the Conference happening?

- Federalist wish for EU reform
- Promise that got EC President
   Von der Leyen elected in 2019
- Others could not say 'no' to a proposal for transnational debate and citizen participation

Note: citizen participation in the Conference was no end in itself



#### The selling point of the Conference: inclusive deliberation



#### How inclusive is the Conference *really*?

- Citizens' panels: exclusion of EU residents without EU citizenship, gender binary approach to participant selection, no quota for racialised and other marginalised communities
- Plenary: no representation of marginalised communities, apart from President European Disability Forum
- No strategy on including marginalised communities and creating a safe space for all



60+ civil society organisations

#### What to expect from the follow-up?

"[T]he Plenary will on a consensual basis put forward its proposals to the Executive Board. [...] Based on the Conference Plenary's discussions and proposals, the Executive Board, acting on a consensual basis, shall draw-up a report, in full collaboration and in full transparency with the Conference Plenary, which will then be published on the Multilingual Digital Platform. [...] The final outcome of the Conference will be presented in a report to the Joint Presidency. The three institutions will examine swiftly how to follow up effectively to this report, each within their own sphere of competences and in accordance with the Treaties."

### My conclusion: success story or lost cause?

- **EU needs fundamental self-reflection** on past & present actions how it has contributed to perpetuating global inequality and injustice in order to shape a better future for itself and for the world
- Marginalised communities need to be at the center of any such reflection & participation exercises: "when they enter, we all enter" (Kimberlé Crenshaw)
- Conference in current form is symptomatic of what is wrong with the EU
   it deflects from the root causes of European societal problems, it further marginalises those already marginalised and it keeps the people divided
- Civil society should reflect on its own role and responsibility in the way the EU has been shaped up until today it should prioritise building ties of solidarity with the most marginalised and push itself, the Conference and the EU as a whole to do better
